## Supplementary Regulations

**ANNOUNCEMENT:** - Castleside Trials Club will organise an 'Open Permit' Trial for solo motorcycles, held under the National Sporting Code, Standing Regulations of the ACU, the following Supplementary Regulations and any final instructions issued for the meeting.

**ELIGIBILITY:** - Open to registered members of the ACU. All riders and passengers must hold a current ACU Trials Registration /Membership or a SACU licence or ACU/SACU rider's licence. Any rider or passenger from another FMN MUST produce a licence issued by their FMN together with start permission and proof of personal accident Insurance. (Registrations will be checked at signing on).

**MACHINES:** - Motorcycles as per NSC Appendix D Category 1, Group A1 Solos and TSR 8.

**CLASSES:** - Pre75, Air-Cooled Monoshock and Twinshock motorcycles (As per Rockshocks Regulations)

**START / VENUE:** - 12 pm Saturday, 10 am Sunday at Low House Haven Edmondbyers Consett DH8 9NL

Signing-on area will be clearly signed.

**RESULTS:** - will be e-mailed to those competitors who provide an e-mail address, published on our website and other public domains and the Castleside Facebook page by the evening of the trial if possible. A Report on the event may appear in TMX (Trials & Motocross News)

**AWARDS** for the Series will be made at the end of the season and presented at the Telford Show.

**COURSE:** - All on private land, to consist of 2 laps of 15 sections Saturday and 2 laps 20 section Sunday with TWO courses – Expert (Red/Blue flags) and Clubman (Yellow flags). Sections shall be ridden in correct order on each lap. The onus on finding the sections is that of the competitor, the route will be clearly marked and should be closely followed.

**METHOD of MARKING:** - As per TSR 22b (no stop). Ties will be resolved as per TSR 23

**PROTESTS:** - should be e-mailed to the Organising Club within 7 days of the Results being published; the arbitration of any protests will be reviewed by the Rock-Shocks Classic Trials Championship Organisers, generally as per the National Sporting Code of the ACU, section 10.04

**DO NOT RETURN TO THIS VENUE FOR PRACTICE PURPOSES / NO PRACTISING BEFORE OR AFTER THE EVENT.**

There will be a Prize Draw for Observers on both days courtesy of Rock Shocks, with cash prizes of £100, £50, £25.
